TABLE OF FEES PAYMENTS AND SUMS fixed and settled in accordance with Statutory Instrument No. 204 (The Local Authorities Cemeteries Order 1977)

The fees, payments and sums set out below on the left-hand side apply where the person to be interred or in respect of whom the right is granted is, or immediately before his or her death was, an inhabitant or parishioner of the PARISH of WOODNEWTON. The fees payments and sums shown on the right-hand side pertain to persons to be interred not an inhabitant or parishioner of the PARISH of WOODNEWTON.
